Identity of the Data Controller	You have provided, are about to provide or will provide personal data to the Association of Football Federations of Azerbaijan (AFFA) of 2208 Nobel Ave, Baku 1025, Azerbaijan (the " Host Association "), acting as data controller (via the Ticket Agent, if applicable) (as defined in the UEFA EURO 2020™ Ticketing and Hospitality Terms and Conditions–Ticket Sales by the Association of Football Federations of Azerbaijan) (the " Terms and Conditions ").
Purposes of the processing	The personal data are collected and processed for providing the Buyer (as defined in the Terms and Conditions) with Ticket(s) (as defined in the Terms and Conditions) and in this respect for organising the Match(es) (as defined in the Terms and Conditions) and/or for the purposes of any relevant safety, security and sanitary measures (including sanitary measures in the context of COVID-19) related to the relevant Match(es).
Legal basis	The personal data are processed on the basis that such processing is necessary: <ul style="list-style-type: none">- for the performance of the contract which may be entered into between the Host Association (via the Ticket Agent, if applicable) and the Buyer,- for the legitimate interest of guaranteeing an effective security system and safe environment inside and around the Stadium (as defined in the Terms and Conditions), and combatting the unlawful sale of Tickets.
Categories of recipients	You understand that the personal data will be available to the Host Association (and the Ticket Agent, if applicable) and any third party appointed by the Host Association to assist in the organisation of the relevant Match(es). The Host Association may transfer certain personal data to these recipients for the sole purpose of the performance of their activities related to such Match(es): <ul style="list-style-type: none">- UEFA, as the exclusive owner of the commercial rights relating to UEFA EURO 2020™ and an independent data controller, to guarantee an effective security system and safe environment inside and around the Stadium and combat the unlawful sale of Tickets.- the relevant Stadium Owner (as defined in the Terms and Conditions), Stadium security and access service providers and any such other providers which help to organise the Match and maintain safety and security.

Onward transfer	Certain personal data may be further transferred to any relevant public authorities, based on legal provisions and obligations, for the purpose of safety, security and sanitary measures related to the relevant Match(es). The Host Association will implement appropriate safeguards in the event of a transfer of personal data to the parties identified above located in a country which does not ensure an adequate level of protection within the meaning of applicable data protection laws.

Retention period	The personal data is only collected and processed by the Host Association for no longer than is necessary for the purposes described above, unless the use of such personal data is further required for ongoing administrative or judicial proceedings relating to the Match or, where necessary, for preventing or detecting unlawful actions.
